TERMS & CONDITIONS

LIABILITIES

All hair stylists and make up artists shall not be held responsible for any allergic reactions, injuries or adverse effects resulting from the use of hair or make up products, styling tools during the service. The client is responsible for informing stylist or artists or any allergies or sensitivities.

PAYMENTS

The client agrees to the following payment terms:

- ♦ A non refundable deposit of \$ 100 is due at the time of booking to secure the date of the event.
- ♦ The remaining balance of the total agreed-upon fee is due 7 days prior to the day of the event.
- ♦ Payments can be made via cash or electronic transfer.

PHOTOGRAPHY

The client grants permission for the hair stylist and or make up artists to take photographs during the session for their portfolio, website, social media and or promotional materials unless otherwise specified by the client. Any sensitive or private images will not be shared without the client's consent.

TRAVEL

If the event location is not within the local area or the stylist or artist base location, the client agrees to cover the following travel expenses:

- ♦ \$.93 per kilometre for round trip.
- ♦ Parking & Tolls: Client will cover any parking fee or tolls associated with the travel to the event location.
- ♦ Accommodation (if applicable): Client is responsible for providing and covering the cost of accommodation for the hairstylist and or make up artist if the event requires an overnight stay.

CANCELLATIONS

In the event that the client wishes to cancel or reschedule the event, the following conditions apply:

- ♦ Cancellation or rescheduling must be made at least 30 days prior the the event date.
- ♦ In the event of cancellation due to unforeseen circumstances, responsible efforts to reschedule the appointment or provide a refund, minus any costs incurred.

CLIENT RESPONSIBILITIES

The client agrees to:

- ♦ Provide a clean and well lit area for the hair stylist and make up artists at the event location, if unable to provide alternate location must be offered or service will be refused.
- ♦ Arrive with clean dry hair on the day of the event as specified by the hair stylist.
- ♦ Communicate any changes in the even details, hairstyles or make up style with stylist or artist in a timely manner.
- ♦ Be punctual and ready for the hair stylist or make up artist to ensure that the schedule is maintained.
